

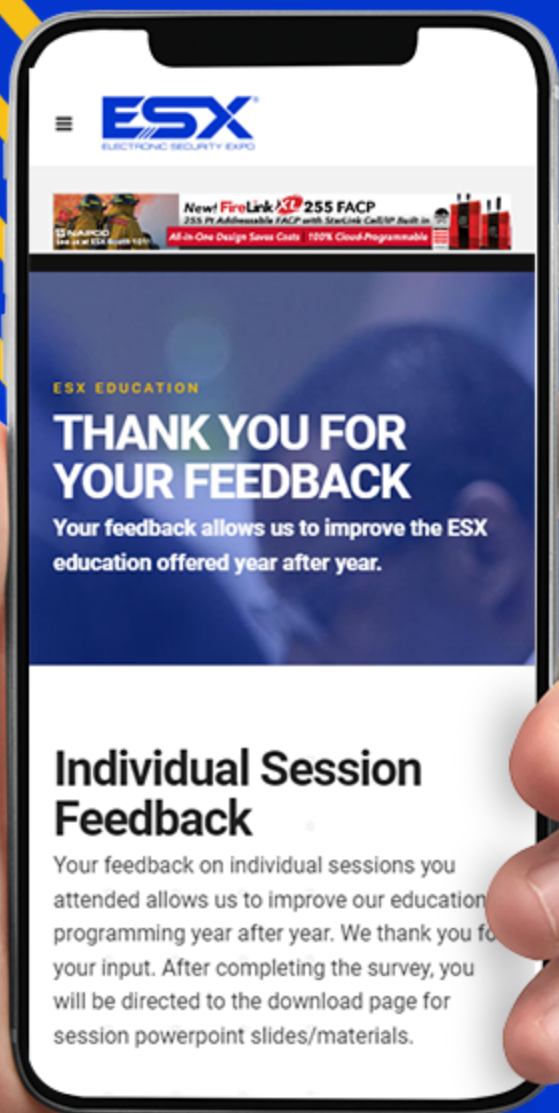

# FCC order 19-72A1

- This FCC Order allowed price cap incumbent LECs (ILECs) (such as AT&T, Verizon and CenturyLink) to cease complying with certain requirements that provided benefits to competitive LECs, effective August 2, 2022.

# FCC order 19-72A1

- The FCC also has taken other actions that are leading to the retirement of copper lines and the discontinuance of TDM service. Specifically, the FCC has made it easy for carriers to discontinue TDM service by streamlining the section 214 discontinuance process and to retire copper lines by streamlining the network change notification process.
